RE: FY 2024 - 27 HRTPO TIP Amendment UPC 119217

Dear Mr. Crum,

The Virginia Department of Transportation (VDOT) requests a TIP Amendment from the Hampton Roads Transportation Planning Organization (HRTPO) to revise the cost estimate, description, schedule, allocations, and obligations for UPC 119217, #SMART22 #SGRVB I-64 Denbigh Boulevard Interchange, to the FY 2024-27 TIP. This project will install the first phase of a full interchange on I-64 at Denbigh Boulevard. Increases in the project cost include repairs to the existing retaining wall due to settlement and incorporating bridge abutment improvements to minimize disturbance to bridge approach fills. This TIP Amendment request is only for the repairs and abutment improvements. Fiscal constraint of the subject project is demonstrated outside the FY 2024-2027 TIP, but within the FY 2025-2030 VDOT SYIP. To that end, we request UPC 119217 be revised to the FY 2024-27 TIP including the following information:

- UPC 119217 – #SMART22 #SGRVB I-64 Denbigh Boulevard Interchange
 - Non-Federal Oversight
 - Revise Project Title to be:
 - I-64 Denbigh Boulevard Interchange – Phase 1
 - Revise Project Description to be:
 - Phase 1 of a full interchange at Denbigh Boulevard, including WB off-ramp, widening of I-64 to support off-ramp, I-64 WB on-ramp and signal, widening of Denbigh Boulevard, and intersection improvements for Denbigh Boulevard/Warwick Avenue/Jefferson Avenue. Also includes repairs to the retaining wall due to settlement and incorporates bridge abutment improvements.
